MEMORANDUM OF UNDERSTANDING

This **Memorandum of Understanding** (here in after called as the 'MOU') is entered into on this day 5th March Twenty Thousand and Twenty-four between

OBJECTIVES OF MOU

This MOU is intended to: -

1. Enhance entrepreneurial mindsets among the students by organizing workshops and training programs including startups, generating self-employment opportunities and the placements.
2. To exchange information regarding educational programs, teaching, learning material and other relevant information for faculty and students.
3. To jointly organize seminars, conferences, or workshops on topics of mutual interest and to invite each other's faculty and students to participate therein.
4. To exchange on reciprocal basis, students at under graduate and graduate levels for limited period for the purpose of education and upgradation of knowledge and skills along with the short duration faculty exchange programs.
5. To increase collaborations and linkages
6. To provide guidance, knowledge, and encouragement

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

Clause-I

Cooperation

Both parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective cooperation's. The parties shall keep each other informed of potential opportunities and share all information that may be relevant to secure additional opportunities for one another.

Clause-IV

Validity

The validity of the agreement is three years from the date of agreement. The MOU will take effect from the date it is signed by representatives of both the parties. It will remain valid for three years, and may be continued there after suitable review and agreement. Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of termination both the parties will have to discharge their obligations.

Clause- V

Arbitration Clause

Should there be a dispute relating to any aspect of the MOU, Principal Govt. College Sector-9, Gurugram and Head/Manager/Director of the institute/ company of Second Party will jointly resolve the dispute in a spirit of independence, mutual respect, and shared responsibility.
